Report of the Trustees for the year ended 28 February 2020

## **Status of Charity and Governing Document**

New Team SCIO was registered as a Scottish Charitable Incorporated Organisation on 28 May 2014. The charity registration number is SC044882. The charity was previously registered as an unincorporated association. It has a single tier structure and as such the trustees are the members of the charity.

#### Recruitment and appointment of Trustees

An individual, nominated individual or body can apply to become a trustee of New Team. Any applications will be considered by the Trustees, and acceptance is wholly at their discretion. The maximum number of trustees is thirteen and the minimum number is three.

# Objectives and activities

#### Charitable purposes

The organisation is founded on Christian principles and is established for charitable purposes only. The object is the advancement of citizenship or development of community, in particular:

- Making relationships with young people who have few positive relationships and avenues for support and help them realise their full potential.
- Identifying the needs and interests of young people and develop appropriate strategies for action, either by New Team or with other agencies.
- Working with young people towards their personal, social, and spiritual development and to
  encourage young people to take more control over their lives, in line with youth work
  principles.
- Helping bridge gaps in understanding between the local community and young people.

# Objectives and activities (continued) Charitable purposes (continued)

- Signposting adults to organisations and services in a way that aids their empowerment as parents, carers and members of a supportive community for young people.
- Undertaking research into new ways of working with marginalised young people and their communities.
- Developing new expressions of church, with those young people and community members who are interested.
- Supporting projects with similar objectives both locally and globally.

#### **Activities**

New Team activities were street youth work (detached work) and youth work trips. Fundraising activities included grant applications and promotion through social media.

## Achievements and performance

In the summer of 2019, we expanded the detached work to a second location. Groups of young people, especially young men had started hanging out in there: so, after mapping in the spring to get a sense of the young people's patterns, we discerned this would be a valuable street work location. Sadly, about a month after we started detached work there, all three members of the detached work team became unwell with a variety of separate illnesses, two of us for the rest of the summer. When detached work resumed in the autumn, we continued engaging with these groups, before they disappeared from the streets for the winter. This was a new experience as young people we had previously worked with had remained in the same locations year-round. Meanwhile, in the original area, there have been fewer young people, as the group we worked with in the past have grown out of youth work. We began to see a new group there in the autumn before they also disappeared for the winter, but we hope to work with them in the summer of 2020. Through 2019/20 we developed more youth work activities with one young person from this area, taking them on trips and starting to meet them more regularly. This included some trips to coffee shops, a trip to a restaurant and a go-karting trip, which have all been great opportunities to strengthen this relationship and offer support. We had some faith-based conversations including some informal bible studies. We also worked with them on the design of the building refurbishment (see below), getting their input on the layout, what to have in the building and on décor. This has been the progression of a long-term relationship over many years.

We said goodbye to the youth worker focused on young men (17 hours), who was blessed to move on to a full-time youth work job. We used this opportunity to restructure, recruiting two new youth workers working 7 hours each as this gives us more flexibility. They were trained over the winter months and began detached work. They look forward to expanded detached work for the summer of 2020. During this time, we anticipate offering youth work on the streets at a time when building based youth work faces restrictions. Detached work offers the opportunity to restart youth work earlier than building based work, working more freely with groups and bringing education on the restrictions to the spaces where young people are. We also recruited some new volunteers. This includes two new trustees, Clare (secretary) and Alison (treasurer).

This year we have also worked towards having a building, a small shop space that will be refurbished as a youth work space, base and office. Change of use planning permission was granted and a few weeks after the end of the financial year, the building warrant came through.

This allows us to replace the very old toilet space with a newly constructed unisex disabled toilet and to install a kitchen. We look forward to signing the lease in 2020 once the landlord's staff return from being furloughed during lockdown. We plan to involve the young people in the refurbishment as far as restrictions at the time allow. This will give the young people ownership of the space, build community and help them develop new skills. The building will allow us a space to strengthen youth work relationships that begin on the street.

#### **Financial review**

The trustees are grateful for the financial support of individual donors, along with our grant funders: The Allchurches Trust Ltd, The Anchor Foundation, The Arndee Trust, The Bellahouston Bequest Fund, Dr Guthrie's Association, The J&C Fleming Charitable Trust and The Hope Trust. The trustees would also like to thank all volunteers for the donation of their time. During the period all expenditure was on charitable activities.

# Results for the year

The financial statements for the year are set out on pages 5 to 8. The Receipts and Payments Account on page 5 reflects a surplus for the year of £2,436 (2019: £13,957).

# Reserves policy

It is the policy of the charity to maintain unrestricted funds at a level which equates to approximately three months unrestricted expenditure. This allows sufficient funds to enable the ongoing work of the charity to be maintained. The General Fund on page 6 at 28 February 2020 amounted to £15,304 (2019: £14,398), which is above the required level. Total reserves, including restricted funds, amounted to £25,274 (2019: £22,838).

Report of the Independent Examiner to the Trustees for the year ended 28 February 2020

I report on the accounts of the charity for the year ended 28 February 2020 which are set out on pages 5 to 8.

#### 1. Accounting policies

*Unrestricted* funds comprise donations, grants and other income received for the objects of the charity without further specified purpose and are available as general funds.

**Restricted** funds comprise income which has been received for the objects of the charity and specified for a restricted purpose within these objects by the donor.

# **Explanation of funds**

The Anchor Foundation Fund - represents money given towards the costs of youth work premises and youth workers salary.

The J&C Fleming Charitable Trust Fund - represents money given towards youth worker funding.

The Matched Funding for Project Leader Fund - represents money specifically given for the Project Leaders salary by individual donors.
